Withdrawal:

This contract may be terminated by either party with two weeks' written notice. Notification of withdrawal by a Parent/Guardian must be made to the Nursery School Director at Cassville Nursery. Your child is considered enrolled and you will be charged until written notice is given. The deposit will be returned upon withdrawal. Any outstanding fees, late fees and fines will be deducted from the deposit.
